Re: The Flats at Carriage Commons Phase I & II

Dear Mr. Benson:

Please accept our letter of support for The Flats at Carriage Commons – a transformational, transit-oriented development that will create up to 210 affordable homes next to a transit center in Northern Michigan. The Michigan Legislature has demonstrated their support of the Project via a \$6 million commitment in the 2023 fiscal year budget and we are hopeful that MSHDA will consider funding this invaluable transit-oriented development under its "Strategic Investment Category."

The Traverse City Housing Commission (TCHC), in partnership with Smith & Henzy Affordable Group, Inc. ("Smith & Henzy"), will be submitting a 9% and 4% blend Low Income Housing Tax Credit (LIHTC) application to MSHDA to bring the first 118 apartments, a community clubhouse, and other amenities, such as walking trails, a picnic area, and open greenspace to fruition. The Flats is slated for development near the corner of LaFranier Rd. and W Hammond Rd. in Garfield Township, just south of Traverse City in Grand Traverse County.

With a mix of studio, one-, and two-bedroom apartments for individuals and families with incomes from 30%-80% AMI, this project will house some of the community's most in need – our low-income workforce. While Grand Traverse County has been a desirable locale for many years, with the onset of COVID-19, an increase in remote work, and thus, the ability for families to seek homes in Northern Michigan, demand for housing in the Traverse City area has skyrocketed. Service and essential workers have been left scrambling to find affordable apartments that are near transit and employment centers.

While TCHC and Smith & Henzy are developing the residential portion of The Flats, the Bay Area Transportation Authority ("BATA") is developing its new headquarters and bus transfer station on the project site, which will give residents unmatched access to public transportation and therefore, to the amenities, recreational opportunities, and employment centers throughout the region. Residents will have the ability to take reliable, convenient, and affordable public transit from just outside their front doors. This proximity to transit, particularly in a non-urban setting, is what makes The Flats truly innovative and deserving of MSHDA's finite resources.

We implore MSHDA to award 9% LIHTC to The Flats at Carriage Common under the "Strategic Investment Category," which was created to reward projects such as this for leading the way in transforming their communities. Thank you for your time and consideration. Please accept this letter of support from the Northwest Michigan Community Development Coalition. Thank you for your consideration of the Grand Traverse Band of Ottawa and Chippewa Indians' proposal to the Restoring Tribal Priority Fish Passage through Barrier Removal under the Infrastructure Investment and Jobs Act.

The Grand Traverse Band of Ottawa and Chippewa Indians is leading efforts to collaboratively improve freshwater habitat in northern Michigan. They will use this funding to replace undersized infrastructure at road-stream crossings to reconnect 49 miles of stream. Funding also will enhance the capacity of the Tribe and its northern Michigan partners to advance future fish passage projects.

These combined efforts will improve habitat for native brook trout and other Great Lakes fish species that utilize river and stream habitat for a portion of their life cycle in the Black River, Thunder Bay River, Jordan River, Pere Marquette River, Lake Leelanau, Glen Lake-Crystal River, and Manistee River watersheds. This effort builds on a similar collaborative initiative led by the Tribe through the USDA Regional Conservation Partnership Program to restore Tribal fisheries by replacing undersized road-stream crossings and protecting high-quality farmland from development. These efforts, including the proposed project, have had broad ranging benefits to habitat which benefits the local Tribal community as well as the broader northern Michigan community.

Improving freshwater resources is a shared strategic priority for this Coalition, therefore we are in support of the Tribe's pursuit of this impactful funding opportunity. We look forward to supporting them in the implementation of this meaningful work, and we thank you for your thoughtful consideration of this request.
